### INTERNAL RISK FACTORS

# The below mentioned risks are the top five risk factors as per the Letter of Offer:

- 1. Our business depends on the availability of reasonably priced and high-quality raw materials in the quantities required by us. We procure raw oil from various suppliers scattered in different regions in India. Edible Oils timely availability and also non-availability of good quality raw oil from across the country could negate the qualitative and quantitative production of the various products of our Company. Volatility in oil prices is another major risk for this segment.
- 2. In Fiscal 2021, Fiscal 2022 and six-months period ended September 30, 2022, our revenue from sale of groundnut oil and coconut oil products in Maharashtra was ₹7,440.25 lakhs, ₹7,916.75 lakhs and ₹3,905.30 lakhs, respectively contributing towards 71.89%, 66.78% and 65.66%, of our revenues from operations, respectively. We will depend on the sale of our oil products especially coconut and groundnut oil for a majority of our income in the near future. Therefore, factors such as change in consumer preference for these oils in Maharashtra region may have an adverse impact on our total income. For us to grow in this region and other parts of country, we will have to put efforts in marketing our product in such a manner that consumers are attracted and we are able to build more consumers.
- 3. Our Company is currently involved in a number of legal proceedings. These legal proceedings are pending at different levels of adjudication before various courts and tribunals. The summary of pending litigation in relation to criminal proceedings, tax proceedings, arbitration matters and actions by regulatory or statutory authorities and other material pending litigation involving our Company has been set out below:

We cannot assure you that we will be able to successfully identify and appoint new distributors or effectively manage our existing distribution network. If the terms offered to such distributors by our competitors are more favourable than those offered by us, distributors may decline to distribute our products. If our distributors fail to distribute our products in a timely manner our business and results of operations may be adversely affected.
